7th Eco-products International Fair in New Delhi, India – Green Productivity for Sustainable Energy and Environment –

The Asian Productivity Organization (APO) will organize the 7th Eco-products International Fair (EPIF 2011) showcasing the most advanced environmental technologies, products, and services at Pragati Maidan in New Delhi, India, 10–12 February 2011, jointly with the Department of Industrial Policy & Promotion, Ministry of Commerce and Industry, Government of India, National Productivity Council, and Confederation of Indian Industry (CII).

The EPIF is the largest international environmental fair in Asia and this year will be held concurrently with the International Engineering and Technology Fair. The EPIF 2011 will promote environmentally friendly business practices and environmental cooperation by exhibiting the latest eco-products, -services, and -technologies, as well as corporate social responsibility activities. The Japan Pavilion organized by the Japan External Trade Organization and sponsored by the Agency for Natural Resources and Energy, Ministry of Economy, Trade and Industry, will focus on energy conservation and renewable energy.

In addition to the fair, a two-day parallel international conference will be held on environmental issues in the Asia-Pacific. The presentations and panel discussions will be attended by high-level government officials, business leaders, and representatives of leading research institutes and international organizations.



During the fair, the 2011 edition of the *Eco-products Directory* will debut. The *Eco-products Directory 2011* contains the latest eco-products, -materials, -components, and -services compiled by the APO under the guidance of Dr. Ryoichi Yamamoto, Emeritus Professor, University of Tokyo.
