7. Background

Productivity issues in the public sector have been identified as one of the top priorities by many APO member economies in recent years. To address the challenges, the APO has been enhancing its public-sector productivity (PSP) work with various initiatives such as adapting basic productivity tools and techniques for the sector and strengthening performance management systems to drive innovation. The APO has also developed a PSP framework that guides NPOs and public-sector organizations in member economies in adopting coordinated approaches to promote innovation and productivity increases.

Reflecting its importance, the 57th Session of the Governing Body in Bangkok, Thailand, in April 2015 approved the establishment of the APO Center of Excellence on Public-sector Productivity (COE on PSP) within the Development Academy of the Philippines. The COE on PSP will undertake various activities to facilitate learning, innovation, and sharing of knowledge and best practices among member countries. Key activities of the COE on PSP include R&D on materials to strengthen its capacity and disseminate know-how to other countries through multicountry workshops, conferences, training courses, and assignment of experts.

One area that requires more R&D is suitable benchmarks for PSP performance. The lack of these benchmarks makes it difficult to measure, compare, and improve productivity systematically. This research mission to Europe will help address this critical issue by looking into advanced PSP practices and standards in European countries.

The research mission will coincide with the First Public Sector Performance Study Mission in Europe to be held from 27 September to 2 October 2015 in three countries: Belgium, Germany, and Luxembourg. Participation in this international event will provide in-depth insights into the approaches, frameworks, and strategies of best practice organizations, as well as a closer look at business excellence practices in the public sector. These will broadly cover key PSP topics for the APO such as leadership, human resources, citizen and customer focus,

performance measurement, innovation, knowledge management, and measurement of productivity in public-sector organizations in European countries.

As one of the first major activities of the COE on PSP, this research mission is expected to present key findings from advanced European PSP practices and recommendations on the approaches, frameworks, and strategies of PSP initiatives in APO economies.

8. Positioning of this Research Mission under the COE on PSP

The COE on PSP consists of four pillars:

- a. PSP Knowledge Center: serves as an online repository on PSP knowledge products derived from APO projects;
- b. PSP Capability Development Program: provides face-to-face and online training, seminars, etc. for APO member countries for PSP knowledge transfer;
- c. PSP Innovation Library: serves as a venue for NPOs and public organizations to obtain first-hand information on applying PSP tools and concepts; and
- d. PSP Research Program: studies emerging trends and practices in PSP and develops tools and techniques to strengthen the capacity of the COE and transfer knowledge to other NPOs and public organizations.

This research mission will fall under e) the PSP Research Program to study advanced practices as well as develop tools and materials to be shared with other member countries and used for the future activities of b) PSP Capability Development.

9. Expected Mission Outcomes

The expected output of this research is a comprehensive report by experts containing the following:

- a. Recent trends and advanced practices of PSP and performance in Europe that may be adapted for APO member economies;
- b. Best practices and policies that encourage the development of productivity indices to measure cross-national, national, and organizational PSP; and
- c. Other emerging trends, opportunities, tools, and techniques that could be utilized for APO programs on the PSP.

10. Research Schedule

The primary activity of the research mission is to participate in the First Public Sector Performance Study Mission in Europe to be held from 27 September to 2 October 2015 in three European countries: Belgium, Germany, and Luxembourg. This will be followed by discussions between the experts and report writing.

Report Writing and Submission Timeline

The final output of the research mission will be the research report by experts covering the findings, chronicles of best practices learned from European countries, and recommendations for the APO to consider in improving PSP performance in the region. The final research report by experts will be submitted to the APO by December 2015, two months after the research mission.
