Objectives	Evaluate the implementation of The Malaysia Productivity Blueprint (MPB) including its Productivity Nexus project since its inception in 2017; examine productivity issues, challenges, opportunities, and project effectiveness; and propose revisions to the productivity roadmap for the Productivity Nexus, addressing challenges and opportunities at both sectoral and enterprise levels.
Rationale	The MPB aims to raise economic productivity and competitiveness in sectors like agriculture, manufacturing, construction, and services. In response to the dynamic business environment, ongoing efforts seek to identify and implement strategies to improve productivity efficiently by addressing challenges and capitalizing on opportunities.
Background	The 2017 MPB was designed to augment the productivity and competitiveness of Malaysia's economy. It covers agriculture, manufacturing, construction, and services. Emphasizing the pivotal role of the private sector, it introduces 11 Productivity Nexus points led by prominent figures in key economic sectors. A total of 114 projects have been identified in these sectors, with the goal of elevating productivity at both sectoral and enterprise levels. Malaysia's productivity growth lags behind that of numerous East Asian countries, particularly in comparison to the ROK, resulting in a productivity gap of USD29,188 per worker in 2021. It is imperative to identify effective strategies for productivity enhancement. Ongoing endeavors seek to identify optimal approaches to narrow this productivity gap by acknowledging challenges and seizing opportunities for efficiency improvement.
